- ALL After School Care fees will be charged and collected through FACTS Management.
- Parents will be charged an additional \$1.00 each minute a child is picked up late.
- All students who are not picked up at dismissal and are not participating in an after-school activity, **MUST** go to the appropriate After School Care classroom until their parent /guardian arrives to pick them up. Parents will be charged the \$30 Drop-In fee through FACTS.
- Students participating in any After School activities will be sent to After School Care if not picked up on time when the activity ends, and parents will be charged the \$35 Drop-In fee.
